


Ed Werder back at BSO


Criminal Justice Merger

Roy said he is blessed to have served with so many dedicated officers and staff who are truly committed to serving the community in a professional manner.


He will be starting a second carreer with the Monroe County Florida Sheriffs office in the Naples area .Roy is deeply admired and respected by his peers and the community he served.
