Judge Of The Year, George w. Brescher


Judge Brescher Honored Feb. 24,05

This Commission was proud to have selected Judge Brescher for the Judge of the Year Award 2005.


He has been an Advisory Board Member since 1982 and an avid supporter of the Crime Commission's endeavors in behalf of the criminal justice system.



KEYNOTE SPEAKER - ATTORNEY GENERAL CHARLIE CRIST

Attorney General Crist has worked hard for the people while in the Legislature and was a primary sponsor of the Stop Turning Out Prisoners "STOP" law which was enacted to stop the early release of dangerous prisoners back onto our streets. He explained how a female prosecutor and a female friend were raped, robbed and left for dead with the friend dying. The perpetrator was caught and was found to have just been released several days earlier on an early release program. She asked Charlie Crist if he would sponsor a bill to stop this wanton preying on our citizens. After hearing the story of the horrendous beating and fright that these two young women went through, he decided to lobby his fellow legislators and the "STOP" law was enacted. Mr. Crist is extremely proud of having been involved in this effort. He said that his office is dedicated to making the streets of our State as safe as possible and that his prosecutors work daily to this end.

General Crist lauded Judge George Brescher for his service to the community and for his contribution to the criminal justice system.

He also encouraged the Broward County Crime Commission to continue its endeavors on behalf of the criminal justice system and pledged his support to this Crime Commission and it's goals.
