### CHIEFS MEETING

#### BROWARD COUNTY CRIMINAL JUSTICE "THINK TANK" PROPOSAL PRESENTED

The Broward County Crime Commission, at a May 25<sup>th</sup> 2005 luncheon meeting sponsored by Director James DePelisi, proposed to members of the Broward County Chiefs of Police Association, the creation of a "Broward County Criminal Justice Think Tank". The proposal was enthusiastically accepted unanimously by all present.

Broward County Crime Commission officers present were Frank R. Pinter, Chairman; Peter L. Stevens, President; and Directors James DePelisi and Major James Jones. Also present were Chief John George of Davie Police Dept. and President of the Broward County Chiefs of Police Assn. With him were other members of the Chiefs Assn: Chief Dave Boytell, Sunrise; Chief Duncan Foster, Coral Springs; Chief Dan Giustino, Pembroke Pines; Chief Tom Magill, Hallandale; Chief Larry Massey, Plantation; and Chief Rick Wierzbicki, Wilton Manors.

On Thurs., June 2<sup>nd,</sup> 2005, Chief John George announced the proposal at the Broward County Chiefs of Police regular meeting.


Topics of discussion at the "Think Tank" could include: budgets, training, recruitment, inter-agency cooperation, equipment, communications, shared intelligence, anti-crime strategies and all matters of concern to the criminal justice community.

Networking and familiarity of inter-agency personnel would also be a major goal.

Potential participants would be all Police Depts, BSO, Customs, FBI, FDLE, Fish & Wildlife, Highway Patrol, Immigration, State Attorney, and others, including community input.

The Broward County Crime Commission is willing to partnership with the Broward County Chiefs Of Police Assn. and would assist in the contact and mail-out to all agencies of interest and participate in "Think Tank" sessions.

An implementation planning meeting is scheduled on June 9th,2005. More on this later.

#### NATIONAL ASSOCIATION OF CRIME COMMISSIONS

Frank Pinter and wife, Grace, were invited to a conference of the NACC in Portland, Oregon beginning on May 15<sup>th</sup> thru 20<sup>th</sup>, 2005. Maggie Miller, Executive Director of the Portland Crime Commission, extended the invitation. The conference was sponsored by the Portland Police Department, with arrangements being made by the Portland Crime Commission. Hilton Hotel accommodations were compliments of the Portland Police Department, arranged by Sgt. Michael R. Barkley.

The Portland Police Department conducted a seminar on the battle against methamphetamine labs in their area. Also, Lt.
