Welcome Message - Broward County Crime Commission Criminal Justice Dinner – Thursday, October 18th, 2012

The Broward County Crime Commission welcomes you to the 2012 Criminal Justice Dinner. Tonight's program is certainly a tribute to the fine cadre of men and women who professionally carry out their duties day in and day out to protect the citizens of Broward County.

The role of the Broward County Crime Commission in its support of the criminal justice system is perhaps more relevant now in 2012, than ever before in its 36 year history. Due to an accumulation of crucial concerns over the past 12 years, never before in the history of the United States, have Americans had to deal with such a large composition of life uncertainties.

The increased amount of natural disasters, compounded with the ongoing threat of terrorism, along with the onslaught of cyber crime, have brought a whole assortment of different criminal challenges to the forefront. Moreover, due to an ever evolving wireless electronic age, the amount of Cross Border crime has significantly increased, making opposing criminals more astute, more aloof and more inconspicuous than ever before. This requires law enforcement agencies to be more vigilant in intelligence gathering, as well as having stronger interagency logistical coordination.

Furthermore, a distressed economy brought on by the country's worst ever mortgage crisis, has affected crime in several facets: 1) in many cases, law enforcement agencies are asked to do more with less. 2) due to a suspect economy, the criminal element has suffered set backs with traditional schemes, thereby reinventing itself to spawn and commit different crimes, as a "sign of the times" of the current economy.

These problems were not adherent issues, as little as 15 years ago. Thus, law enforcement, the criminal justice system and the law abiding community have had to transcend themselves to stay one step ahead of the ancillary forces that sometimes work to the advantage of the criminal.

For this reason, the Broward County Crime Commission feels it is imperative to herald and laud the stalwarts of the Broward County Criminal Justice System with the Prosecutor of the Year and the Detective of the Year ceremony. The collection of men and women being honored this evening certainly make our community a better place to live. Thank you for your commitment.

Sheriff Al Lamberti, Broward Sheriff's Office

Sheriff Al Lamberti is a 34-year veteran of the Broward Sheriff's Office.

He began his career in the Department of Detention. After transferring to road patrol, Sheriff Lamberti worked his way through the ranks, eventually serving as a captain in the Organized Crime Division. He then assumed his position as District Chief in Deerfield Beach in January 1990.

After his promotion to Major, Sheriff Lamberti served as Interim Police Chief for the City of Hollywood and North Lauderdale. Soon after, he served as Director of the Training and Organizational Development Division where he oversaw the Center for Advanced Criminal Justice Studies Executive Leadership Program, as well as all day-to-day training functions.

When Sheriff Lamberti returned to the Department of Law Enforcement, he assumed command of the South Patrol Region, which includes Port Everglades and Fort Lauderdale/Hollywood International Airport post-September 11th.

A graduate of the 167th Session of the F.B.I. National Academy, Sheriff Lamberti served as President of the Florida Chapter of the F.B.I National Academy Associates in 2004. He served as President of the Broward Sheriff's FOP Lodge #32 from 1984 - 1985. Additionally, he was the Chairman of the Regional Coordinating Team of the Florida Violent Crime and Drug Control Council for the Southeast Region from 1999 to 2007. In early 2009, Sheriff Lamberti was named chairman of the Region 7 Gang Reduction Task Force by the Attorney General.

Married to Holly for 19 years, he has one son, Nicholas, and two step-children, Jaime and David.

In September 2007, Sheriff Lamberti was appointed Broward Sheriff by Governor Charlie Crist. In November 2008, he was elected by the citizens of Broward County to serve as Sheriff for an additional four years.

WIFREDO A. FERRER, UNITED STATES ATTORNEY PROFESSIONAL SUMMARY

Wifredo A. Ferrer was nominated by President Barack Obama and confirmed by the Senate on April 22, 2010 to serve as United States Attorney for the Southern District of Florida. As United States Attorney, Mr. Ferrer is the chief federal law enforcement officer for the District. Prior to his appointment as United States Attorney, Mr. Ferrer held the position of Chief of the Federal Litigation Section at the Miami-Dade County Attorney's Office.

Mr. Ferrer has a long career in public service. After graduating law school in 1990, Mr. Ferrer clerked for then-District (now 11th Circuit) Judge Stanley Marcus. Upon completing his clerkship, Mr. Ferrer joined the Miami law firm of Steel Hector & Davis in the fall of 1991. After three years in private practice, Mr. Ferrer returned to public service, first as a White House Fellow and Special Assistant to the Secretary of the U.S. Department of Housing and Urban Development (HUD), and later as Deputy Chief of Staff and Counsel to then Attorney General Janet Reno.

After five years at the Department of Justice, Mr. Ferrer returned to Miami in 2000 to become an Assistant U.S. Attorney. While at the U.S. Attorney's Office, he served in the Public Integrity and National Security Section, the Economic Crimes Section, the Major Crimes Section, and the Appellate Division of the Office. As an Assistant U.S. Attorney, Mr. Ferrer handled and tried numerous high profile matters, including international money laundering, health care fraud, narcotics, international human rights abuses, immigration, and firearms offenses.

During his career, Mr. Ferrer has been recognized as one of the Top Government Attorneys by both South Florida Legal Guide and Florida Legal Elite. In addition, he received the Attorney General's Medal in 2000, and Superior Performance and Special Merit Awards for his work as an Assistant U.S. Attorney.

Mr. Ferrer, a Miami native, received his undergraduate degree in Economics (1987) from the University of Miami, in Coral Gables, graduating first in his class. He then attended the University of Pennsylvania Law School where he was an editor of the Law Review, President of his class, and graduated cum laude in 1990. Mr. Ferrer attended Hialeah-Miami Lakes High School, in Hialeah, where he graduated as Valedictorian of his class.

Broward County Crime Commission Inaugural Frank R. Pinter Lifetime Achievement Award

Frank R. Pinter was appointed as the first Chairman/President of the Broward County Crime Commission, and will forever be remembered as the founding father of the agency in 1976. Frank Pinter was a great man; a dedicated man of vision and results to the community. Over the next 30 years, under his leadership, as both president and chairman, the Broward County Crime Commission grew to one of the foremost Crime Commission's in the United States.

Pinter was not only a leader in the law enforcement community, but an individual to emulate. As a 17 year veteran of the Broward Sheriffs Office, he possessed both a diversified and vast background as a detective and criminal investigator. He had previously been appointed by several Governors as a Special Investigator for the Broward County Grand Jury to investigate corruption of public officials. He had also been the Chief Investigator for the Broward County State Attorney's Office.

After Frank's passing in 2007, the Broward County Crime Commission found it necessary to declare the Frank R. Pinter Lifetime Achievement Award. The award was designed to be given to a Criminal Justice representative that understood the importance of the Broward County Crime Commission; and also displayed uncanny results as a Broward County Criminal Justice representative.

Tonight, Thursday, October 18th, 2012, it is the Broward County Crime Commission's privilege to recognize the Pinter family and present Senior Judge Joel T. Lazarus with the Frank R. Pinter Lifetime Achievement Award.

Having served as a Prosecutor from 1978 to 1993, and then a Judge from 1993 to 2010, Joel T. Lazarus has served as the consummate Criminal Justice representative in Broward County. The Broward County Crime Commission found it hard to find someone more deserving than Senior Judge Joel T. Lazarus. The Crime Commission salutes both Judge Lazarus and the Pinter family.

Broward County Crime Commission Inaugural Thomas A. Magill Community Service Award

During his 36 years with the police force, Thomas A. Magill advocated for maintaining a good rapport with residents and was especially a beacon of community service to the children of Hallandale Beach. After becoming the city's chief of police in 2004, he often bicycled through its neighborhoods to gauge what could be improved.

Shortly after becoming the Hallandale Beach police chief, the father of four helped create perhaps one of the greatest crowning achievements ever in the city of Hallandale Beach: the city's Police Athletic League (PAL) program, where he served as its executive director. This endeavor served to be a bright spot of importance to the community, and due to Chief Magill, the Hallandale Beach PAL program today flourishes as one of the finest PAL programs in South Florida.

At schools, he aimed to portray the department in a positive light by working with all students, putting them at ease that the Hallandale Beach Police Department was there to protect them from bullying and to make the streets safer from drugs.

It is for all of these great community achievements (and many others) that the Broward County Crime Commission has declared its Community Service Award after Police Chief Tom Magill.

Tonight, Thursday, October 18th, 2012, it is the Broward County Crime Commission's privilege to recognize the Magill family and present Brian Walsh, owner of Wings Plus, Inc., with Thomas A. Magill Community Service Award.

Having served as a career police officer in New York City, Brian Walsh had a decorated career in which he also knew the importance of serving the community. Upon retirement, he moved to Florida, and eventually started the first of several Wings Plus restaurants in Oakland Park.

However, it is not Brian Walsh's success as a restaurant owner, but what he does with the restaurant in giving back to the community. The Broward County Crime Commission salutes both Brian Walsh and the Magill family.

Michael J. Satz, State Attorney, 17th Judicial Circuit

Mike Satz, a native of Pennsylvania, is a graduate of the University of Miami's School of Law. Following graduation, Mr. Satz became an assistant prosecutor in Broward and quickly developed a reputation as a tough courtroom litigator.

In 1976, he was elected State Attorney for the Seventeenth Judicial Circuit, Broward County and was re-elected in 1980, 1984, 1988, 1992, 1996, 2000, 2004 and 2008.

As State Attorney, Mr. Satz has responded to Broward's diverse crime problems by instituting and expanding specialized prosecution units that focus on cases such as; sexual battery and child abuse, domestic violence, public corruption and organized crime to name just a few.

Mr. Satz, recognizing the needs of victims of crime, instituted a Victim Advocate Unit to provide counseling and assistance to victims. For his efforts, he received the 2004 President's Award by the Broward Victim's Rights Coalition.

Concerned about issues and institutions that affect the people of Broward, Mr. Satz initiated grand jury investigations into Pain Clinic 'Pill-Mills', Broward County School Construction, Youth Gang organizations, Foster Care, Organized Crime activity, the Broward Regional Juvenile Detention Center, Mental Health services and Child Abuse Protections.

In 1995, Mr. Satz sponsored the Broward County Elder Abuse and Exploitation Seminar and in 1999, organized Broward's first Foster Care Summit.

Leadership Broward presented Mr. Satz its annual "Profiles in Leadership" award in 2006. And in 2005, the National Association of Social Workers honored him with the Elected Official of the Year award.

Mr. Satz was honored with the "Community Safety Award" by Legal Aid of Broward County in 2003 and the Broward County Bar Association Board of Directors presented him with the Government Lawyer award the very same year.

In 2001, the Broward County Bar Association presented Mr. Satz with the Lynn Futch Professionalism in Practice award. He has also received the "Heart Award" by the Broward County Children's Consortium in 2000. And he proudly accepted the 1998 Sharon Solomon Advocate Award in commemoration of Broward's late child advocate Sharon Solomon.

Mr. Satz has been recognized by the Broward County Hispanic Bar Association, the B'nai B'rith Justice Unit #5207, the Anti-Defamation League and the Sexual Assault Treatment Center of Broward County, which he helped create.

Mr. Satz was recently presented with the University of Miami's School of Law Alumni Association's annual 'Alumni Achievement Award'.

Each year, Mike co-chairs the successful "Up the River Cruise" as part of the American Cancer Society's annual Jail & Bail event.

2012 Broward County Crime Commission Prosecutor of the Year Award

Maria M. Schneider is the Assistant State Attorney in Charge of the Juvenile Division for the 17th Judicial Circuit of Florida. Since joining the office in 1993 Ms. Schneider had served as a lead attorney in the felony trial division, the Sexual Battery Unit, the Organized Crime and Gang Activity Unit and the Career Criminal Unit.

Upon receiving her JD degree from Nova Southeastern University, from 1986 until 1993, Ms. Schneider was employed as an Assistant Public Defender in Broward County, Florida.

Ms. Schneider is actively involved in numerous community and professional organizations that advocate for the rights and wellbeing of children. This includes but is not limited to: the Florida Bar Juvenile Rules Committee, the Juvenile Justice Board for the 17th Judicial Circuit, and Partners in Education, a non-profit organization that puts businesses and schools together to form coalitions to support student.

From 1999 to 2009 Ms. Schneider was also actively involved in the Broward County chapter of Communities in Schools, a non-profit organization that focuses on dropout prevention.

She also teaches as an adjunct professor at Florida Atlantic University, Nova Southeastern University, and lectures for the Florida Department of Juvenile Justice, the Florida Prosecuting Attorney's Association, the Florida Association of School Resource Officers, the Office of the Attorney General and the National District Attorney's Association. Ms. Schneider was appointed to the Childrens Service Council of Broward County by Governor Rick Scott
