

Broward Chiefs Of Police Association Lunch

Chief Berger spoke at the installation lunch of Sunrise Chief Dave Boyett on January 10th, 2004.

North Miami Beach Chief Berger is the Past President of the International Chiefs of Police Assn, graduate of the FBI Academy, has a Masters Degree in Public Administration, recently received his law degree and has been Chief of North Miami Beach for the past 11 years.

Chief Berger is of the opinion that police administration has changed in past years and that police unions have become a moving force with which the chiefs must deal. He recognizes that the public is aware of forensics and that they may feel that DNA can immediately solve most crimes. In reality, he says it is the sharing of info and the initiatives of the cop on the street that brings perpetrators to justice.

With regard to Homeland Security, Chief Berger said that we, on the local level, need to be represented in Washington much more actively to see that we get the Homeland Funding in order for us to be pro-active rather than re-active.




Chief John George

BIO-TERRORISM INFORMATION PROGRAM

The *Broward County Crime Commission* is sponsoring a presentation of the above program which was developed by Dr. Joshua Perper, MD, - Broward County's renowned Medical Examiner.

All local Police Departments and the Broward Sheriff's Office have been invited to attend this presentation on Wednesday, February 25, 2004 at 2 PM at the Broward Medical Examiner's Office at 5301 SW 31st Avenue, Ft. Lauderdale. Dr. Perper will narrate the program and answer all questions regarding the subject matter. Reservations are required and may be made by calling the Crime Commission at 954-922-2600. A number of departments have already made reservations for their attendance.

Criminal Justice personnel will receive a certificate of attendance and will be given credit for the mandatory retraining requirements for law enforcement.

There will be no charge for this presentation and each department will receive a CD Rom of the program for uce within their department.

The FBI has defined terrorism as the unlawful use of force or violence against persons or property to intimidate or coerce a Government, the civilian population, or any segment thereof, in furtherance of political or social objectives.

Since September 11, 2001, America has changed dramatically. It went from a trusting society to one of constantly being on guard. Emerging threats such as bio-terrorism are difficult to defend against. When bio-defense gives way to bio-response, then pre-planning, adequate training, and public awareness are critical components for a successful outcome. What is a successful outcome? It can only be described as an attempt to minimize the effect on the injury and mortality rate to our citizens.

In keeping with our Homeland Security edicts, we hope that this program and others like it will prepare us to deal with any future eventualities.

UNLAWFUL USE OF BADGES, ETC. - STATE STATUTE 817.311

Any person who shall wear or display a badge, button, insignia or other emblem, or shall use the name of or claim to be a member of any benevolent, fraternal, social, humane or charitable organization, which organization is entitled to the exclusive use of such name and such badge, button, insignia or emblem either in the identical form or in such near resemblance thereto as to be a colorable imitation thereof, unless such person is entitled so to do under the laws, rules and regulations of such organization shall be guilty of a misdemeanor of the first degree, punishable as provided in Florida Statute 775.082 or Statute 775.083.

CRIME COMMISSION UPDATES

The Board of Directors, at our January meeting, voted to once again begin bi-monthly membership meetings. We urge all of our members and directors to attend this upcoming meeting and to support our efforts to make the *Broward County Crime Commission* an even more interesting organization in which to participate.

The Broward County Crime Commission is also working on several other law enforcement initiatives which will be described more fully in a future Newsletter.

One of the programs is the in-depth study of unreported crime in Broward County perpetrated by drug abusers. This study is in the early stages of planning and more on this later.

We are also working closely with Dr. Joshua Perper on developing a forensic accident investigation program which we will present to various police departments for possible use in their patrol divisions.

Our Directors are working with several Chiefs of Police on another major criminal justice initiative to determine its feasibility. More on this at a later date.
