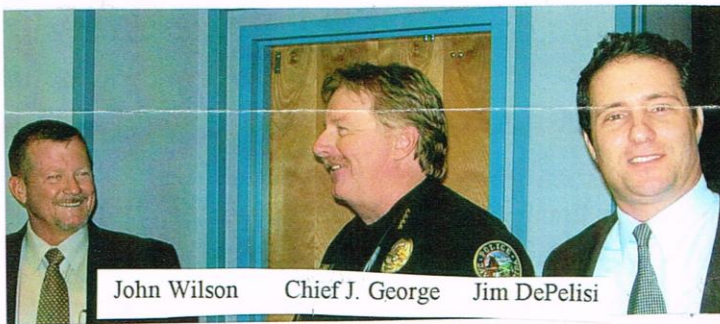

Many other concerns were discussed but tabled to a later date as the recruitment project will be quite extensive and time consuming to get up and running if the project is to succeed.

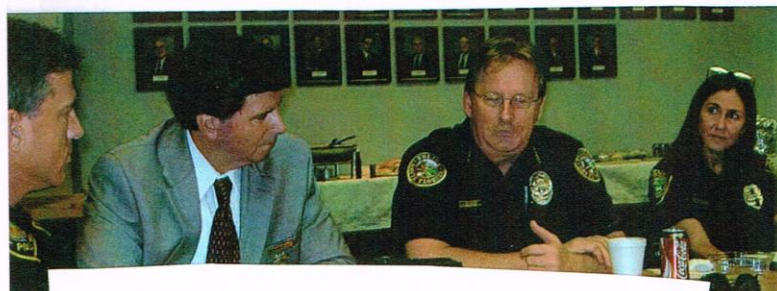
The next **Think Tank Meeting** will be in **November** and all parties will be notified.



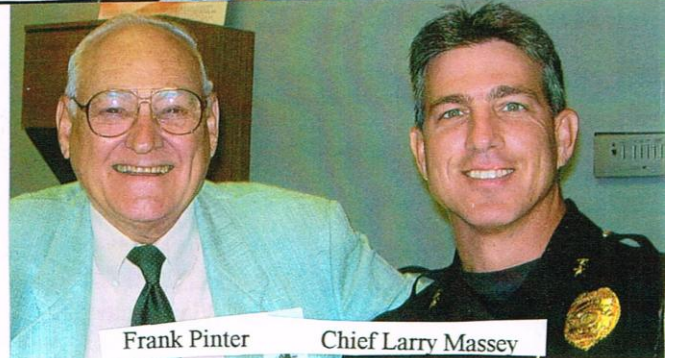

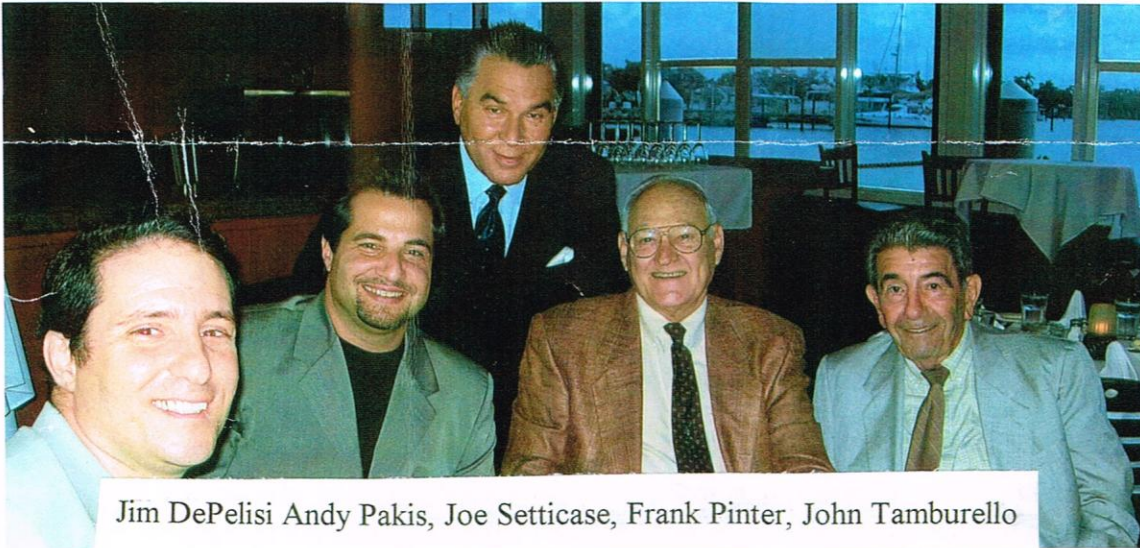
BCCC CRIMINAL JUSTICE SOCIAL EVENT

On Thursday, September 23rd, 2005, we had the first of semi-monthly networking socials for the future.

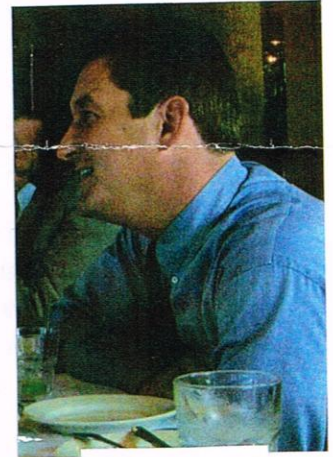

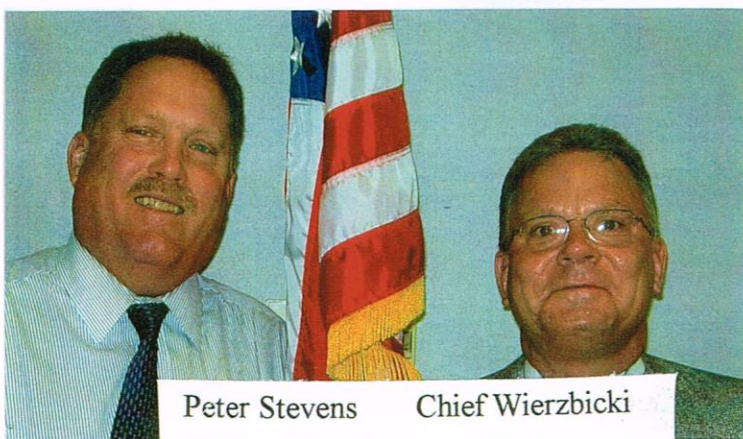

Chief Wierzbicki Appointed

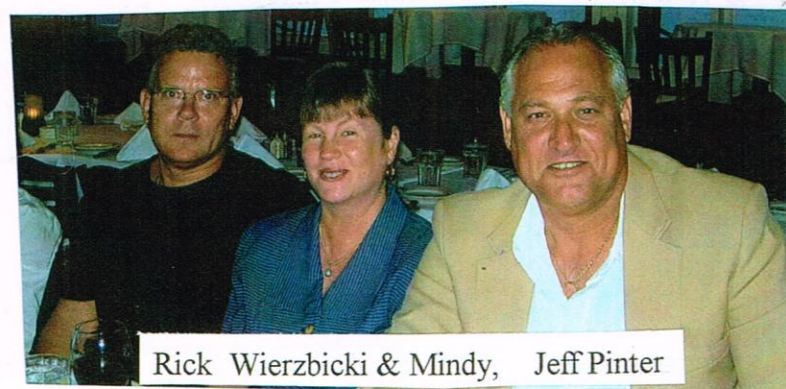
BCCC board of directors voted to appoint Rick Wierzbicki to the crime commission board on September 20th, 05. We welcome and look forward to his expertise
